Summary of EU Parliamentary Workshop "Newborn Infant"

In April, the Workshop on "Newborn Infants", organisd by the European Parliament, highlighted challenges related to neonatal mortality and morbidity as well as preterm births. EFCNI had the opportunity to present the patients' point of view. A document summarising the presentations and discussions at the workshop has recently been published. EU Parliament questions Commission

In July MEP Marc Tarabella (S&D, Belgium) asked the Commission if they would be in favour of treating maternal and newborn health and in particular preterm birth as health priority. We will keep you updated.

Meanwhile, the Commission answered the question by MEP Nuno Melo (PPT, Portugal) on "pregnant woman and iodine supplement", as well as MEP Oreste Rossi's (EFD/Italy) question on "providing better services for premature babies". view more



EU Parliamentary report "Impact of the crisis on access to care for vulnerable groups"

The recently published report on the "Impact of the crisis on access to care for vulnerable groups", written by MEP Jean Lambert, is an interesting document referring also to maternal and child health and in particular preterm babies.



EU Parliament debates draft report on patient safety

Following the publication of MEP Oreste Rossi's (EFD, Italy)

report on patient safety, including the prevention and control of healthcare associated infections, the Environment, Public Health and Food Safety (ENVI) Committee of the European Parliament held their first debate on the issue on 20 June. The report highlights the need for preventative strategies and control mechanisms. Taking simple steps, including basic hand hygiene, can prevent many of these infections and save lives. view more



Decision on preterm infants care in Germany

The Federal Joint Committee (German: Gemeinsamer Bundesausschuss) decided that there should be one caregiver per preterm infant when the baby is requiring intensive care therapy. The "Gemeinsamer Bundesausschuss" is a German public health organisation. The German national association Bundesverband "das frühgeborene Kind" e.V. is very engaged in this topic: warmest thanks for your work! view more

EFCNI visits Erasmus MC-Sophia Children's Hospital in Rotterdam, the Netherlands

On our way to the ESPNIC congress mid of June, we had the great opportunity to visit the Neonatal Intensive Care Unit (NICU) of the Erasmus MC-Sophia Children's Hospital in Rotterdam, the Netherlands, one of the NIDCAP training centres in Europe. At the entrance to the unit, we were fascinated by the "welcome parents" sign in several languages. To our amasement, this represented what we felt during our entire visit – a warm atmosphere where babies and parents receive treatment and care with respect and trust. For example parents are invited to stay with their baby 24 hours and can kangaroo (skin-to-skin contact) even at night.

Many thanks to the NICU team for showing us around and for the fruitful discussions we had. We took home a lot of

Symposium: breast-feeding preterm infants

In June, Medela invited to a one-day training workshop for health professionals on breastfeeding preterm infants taking place in Munich, Germany. Thomas Kühn from the Vivantes Hospital in Berlin-Neukölln, amongst others, explained the importance of breast milk for preterm infants. Family-centred care and the implementation of the ideas of NIDCAP (Newborn Individualized Developmental Care and Assessment Program) are crucial in the treatment and care for preterm babies to improve their development and long-term health.



EFCNI at GNPI congress in Freiburg, Germany

The annual congress of the "German Society of Neonatology and Pediatric Intensive Care" (GNPI) in Freiburg, Germany, was the first occasion for us to present the initiative SOCKS FOR LIFE. The prevention of preterm birth is one major target of EFCNI's work, and we were grateful to attend the national Preeclampsia Congress ("Deutscher Gestose Kongress") in Berlin, Germany. Many experts from all over the country came together for the 2-day congress held mid of June at the campus of the Charité to discuss new findings on treatment and diagnosis, prediction and prevention of preeclampsia.

At the beginning of June, the "Children's Hospital Dritter Orden" in Passau, Germany, invited to the forum PAss' auf, "Newborn Health – Quo Vadis", a multidisciplinary platform for experts in the field of child and family health.
