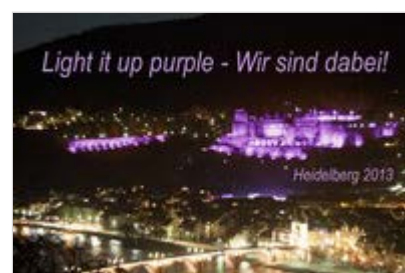
## Give premature babies your voice

This report summarises the presentations and discussions at the Workshop on “Newborn Infants”, held at the European Parliament in Brussels, on Wednesday 24 April 2013. The aim of the workshop was to discuss the challenges related to neonatal mortality and morbidity as well as preterm births, which continue to pose serious concerns for public health and healthcare in Europe. Half a million babies are born prematurely in the EU every year and these infants are at higher risk of developing health problems later in life.

## News by The European Medicines Agency

The Coordination Group for Mutual Recognition and Decentralised Procedures – Human (CMDh), has endorsed by majority the recommendations of the European Medicines Agency's Pharmacovigilance Risk Assessment Committee (PRAC), which concluded that hydroxyethyl-starch solutions (HES) must no longer be used to treat patients with sepsis (bacterial infection in the blood) or burn injuries or critically ill patients because of an increased risk of kidney injury and mortality.

## Black inverted triangle shows which medicines are under 'additional monitoring'

Since 1 September, a black inverted triangle has started to appear in the product information of medicines that are being monitored particularly closely by regulatory authorities. With this measure, the European Commission aims to improve the safety of medicines and also to highlight to patients, the importance of reporting suspected side effects to the medicines they are



taking.
