## MEP Angelika Werthmann questions Commission on prematurity

MEP Angelika Werthmann (ALDE) questioned the Commission about the situation of preterm and newborn infants in Europe, demanding figures for Europe and for each Member State and for the average cost (social services/health costs) of a preterm birth in the European Union. Concerned about the safety situation of preterm- and newborn infants she asked for a statement regarding safe medication and hygiene standards. Answers to her question were given by Mr Borg on behalf of the Commission beginning of January.

## Study: Preemies healthier when cared for by parents during hospital stay

Dr. Shoo Lee, Paediatrician-in-Chief at Mount Sinai Hospital, Canada, developed a new model of caring for preterm infants by positioning parents as the daily care providers in the neonatal intensive care unit. This new model of caring for preterm infants has shown to have a significant positive effect on the baby's health (measurable by weight gain).

## Meaning of „term pregnancy“ redefined

With the aim to improve newborn outcomes and expand efforts to prevent non-medically indicated deliveries before 39 weeks of gestation, the American College of Obstetricians and Gynecologists (ACOG) has redefined their terminology of term pregnancy. They are further dividing term deliveries into early term, full term, late term and postterm deliveries. This change of terminology shall make it clear for patients and health professionals that every day the baby is inside the womb is important to fully develop and have a healthy start in life.

## "When diagnosing preeclampsia, think widely, be alert"

The diagnosis of preeclampsia, a leading cause of maternal mortality worldwide, no longer requires the detection of high levels of protein in the urine (proteinuria). The new diagnosis criteria are described in the American College of Obstetricians and Gynecologists (ACOG) task force report on hypertension in pregnancy. The report reflects the last 10 years of research on preeclampsia and therapy. In particular, it reflects a growing understanding that preeclampsia is a multisystem disease that extends beyond high blood pressure and renal dysfunction.
