

More experience, better outcome

A recently published study reveals that neonatal intensive care units that care for a large number of infants have better results. Babies are 30-50% more likely to survive in busy neonatal centers. Hospitals that gave at least 3,480 days of care each year were classified as "High-volume" in the paper. The study was conducted in England.

EU Clinical Trial Register now with information on results

It is now mandatory for sponsors to post clinical trial results in the European Clinical Trials Database ([EudraCT](#)), the European Medicines Agency (EMA) announced recently. The application is used by national competent authorities to enter clinical trial data, managed by the European Medicines Agency (EMA). Trial results information will be made publicly available via the [EU Clinical Trials Register](#) and summary results of clinical trials from sponsors will become available to the public as well.
