Longer maternity leave in the Netherlands

The Dutch organisation VOC hit a great milestone at the beginning of the year. For more than 6 years they have been advocating for a longer maternity leave in the Netherlands. Mothers are entitled to 16 weeks maternity leave, in general 6 weeks before and 10 weeks after the birth of a child – a time span which is sometimes over when or before the baby comes home from the NICU. Thanks to the hard work of VOC the mothers of preterm babies now get maternity leave of 10 weeks once their baby is at home.

Introducing: New Parent Group in Brazil


The Brazilian Association of Families, Friends and Carers of Preterm Babies Prematuridade.com was formed in November 2014 and is the country's first non-profit organisation for infants born too soon. The organisation emerged out of the website prematuridade.com which was established in 2011 as a hub to support and inform families of preterm babies. The organisation now aims to raise awareness about preterm birth and ways to prevent it. It also advocates for an extended maternity/ paternity leave for preterm parents. At the moment Prematuridade.com is planning a campaign to inform about preterm birth and its consequences and prevention measures in public places in South Brazil.

New EMA Recommendations I

The EMA's Pharmacovigilance Risk Assessment Committee (PRAC) has recommended restrictions on the use of codeine-containing medicines for cough and cold in children because of the risk of serious side effects with these medicines, including the risk of breathing problems. These medications should not be given to children under the age of 12 as well as adolescents under 18 years who have problems with breathing.

New EMA Recommendations II

The EMA's Pharmacovigilance Risk Assessment Committee (PRAC) considers the risk of severe allergic reactions to medicines containing ambroxol or bromhexine small. However, the institution recommends that the product information should be updated with further information on allergic reactions. The medication is used to help clear mucus from the airways.

The strategy is dedicated to ensure that every child in Europe should have every opportunity to live a healthy and meaningful life. Teachers' knowledge of long-term consequences of preterm birth

A new paper by Johnson and colleagues assessed teachers' and educational psychologists' knowledge and training about preterm birth and its long-term consequences in England. The results show shortcomings in knowledge and a need for better training. Although over 90% of respondents thought that they were likely to come into contact with a preterm child, only 38% of teaching staff felt well-prepared to support preterm born children and only 16% of teaching staff had received formal training on the topic.
