Public hearing at German Federal Parliament on paediatric nursing

The petition, submitted by the German paediatric nurse Monika Otte and addressed to the German Federal Parliament (Deutscher Bundestag) reached the requested number of 50,000 signatures. Otte and her supporters had demanded to keep paediatric nursing a separate medical profession. The petition led to a public hearing on 11 April 2016 at the German Federal Parliament with the aim of influencing the legislative procedure.
