




WHO report Good maternal nutrition. The best start in life

The nutritional well-being of pregnant women affects not only their health and their fetuses' development but also children's long-term risk of developing noncommunicable diseases (NCDs) or obesity, according to a new report from the *World Health Organization/Europe*. *Good maternal nutrition. The best start in life* was launched under the auspices of the Minister of Health of Latvia

during a consultation on maternal nutrition, taking place in Riga on 27–28 June 2016.

Multiple birth rates in Europe

A recently published study by *Heino* and colleagues looked at differences in multiple birth rates in Europe and found increased risks for adverse perinatal outcomes in multiple pregnancies. The study used aggregate birth data from the *Euro-Peristat* project for the year 2010.

Survey on cross-border healthcare

Study results from the population-based cohort EPICE

The *British Medical Journal* recently published latest study results from the population-based cohort *EPICE* (Effective Perinatal Intensive Care in Europe). The study by Zeitlin et al. evaluated the implementation of four evidence-based practices for the care of very preterm infants with the aim to assess their use and impact in routine clinical practice.

Suboptimal bonding impairs neonatal development in preterm infants

Findings from a review by Kommers and colleagues suggest that neonatal intensive care units should focus more on interventions that optimise bonding. The authors found that suboptimal bonding impaired hormonal, epigenetic and neonatal development in preterm infants, but these impairments could be reversed by bonding interventions.

Depression and anxiety symptoms in parents of very preterm infants

A research study published in *JAMA Pediatrics* by the *Murdoch Childrens Research Institute* has shown that more than a third of parents of infants born very preterm struggled with depression and anxiety after the birth of their child.
