*Unu si Unu*, one of our partnering parent organisations from Romania, took the next step to establish family-centred care in their country. The organisation won a nationwide contest organised by a pan-European Bank. The funds will be used for the organisation's project *Little human in therapy* that aimed at the implementation of family-centred care. In addition, advanced training sessions in the *Family and Infant Neurodevelopmental Education* (FINE Level 1 and Level 2) programme will be organised and funded by *Unu si Unu* for 100 medical professionals in neonatology in hospitals in Bucharest and Cluj.

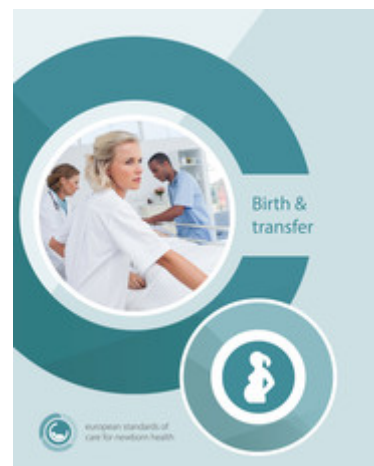

## Newborn survival in Nepal: a community based approach to reduce neonatal mortality

Each year, nearly 35,000 Nepali children die before their fifth birthday, with almost two-thirds of these deaths occurring in the first month of life, the neonatal period. Experts claim that over two thirds of these deaths could be prevented with relatively low costs and low-tech interventions. The Community Based Newborn Care package addresses these issues within the national health system settings of Nepal.

## The use of childbirth practices in Bangladesh – an evaluation of the Safe Childbirth Checklist

In order to reduce maternal and infant deaths, the *World Health Organization* has designed the Safe Childbirth Checklist (SCC), which aims to facilitate healthcare professionals' adherence to essential evidence-based childbirth practices and to reduce maternal and child deaths. Researchers from Bangladesh, Australia, and the US examined the effectiveness of the SCC at a hospital in Bangladesh by compiling a before and after survey.

## New reports on child survival and health coverage

Every year, 2.6 million babies die before turning one month old. However, millions of these young lives could be saved every year. The new *UNICEF* report *Every Child Alive* shows that the risk of

dying as a newborn varies enormously depending on where a baby is born. Another report, *Countdown to 2030*, by *Every Woman Every Child*, synthesises data on the current situation and trends in reproductive, maternal, newborn and child health and nutrition in the context of the 2030 agenda for sustainable development.

## Practical guidance for improving newborn and maternal health

A new manual by the *World Health Organization (WHO)* and *UNICEF* offers practical tools for country programmes and stakeholders to support advocacy for improving newborn and maternal health and preventing stillbirths. It provides a repository of quick references and examples in order to show how to undertake advocacy and communication in various national and local contexts. A second toolkit on intrapartum care brings together new and existing *WHO* recommendations that aim to ensure good-quality and evidence-based care irrespective of the setting or level of health care.

## EU Health Systems: Commission publishes report on Primary Care

The EU Expert Group on *Health Systems Performance Assessment (HSPA)* published its report *A new drive for primary care in Europe: rethinking the assessment tools and methodologies* to help policy makers and health practitioners to set objectives and measure progress towards improving primary care services for the benefit of patients. The report examines core aspects of well-performing primary care systems, focusing on their key functions such as access, coordination of care, and continuity of care.

## New study shows success of the Family Integrated Care model

A new study around O'Brien et al. and principal investigator Dr Shoo Lee in the journal *The Lancet Child & Adolescent Health* shows that the Family Integrated Care (FICare) model helps improve the well-being of both children and parents. FICare actively involves parents in the care of their newborns, including giving oral medicine, feeding, taking their temperatures and taking part in ward rounds. The study showed improved weight gain among preterm infants, better breastfeeding rates and reduced parental stress and anxiety compared to standard care.

## EMA II: Stronger restrictions on the use of Valproate required

The EMA's Pharmacovigilance Risk Assessment Committee (PRAC) is recommending new measures to avoid exposure of babies to valproate medicines in the womb. Babies exposed are at risk of malformations and developmental problems. It recommends strengthening restrictions on their use and introducing new measures to require appropriate counselling and information for affected women.

The German *Federal Ministry of Education and Research* (BMBF) published a guideline on the support of clinical studies with high relevance for patient care. The ministry wants to accelerate the transfer from research findings to practical implementation. Proposals can be submitted by universities, further research organisations, and healthcare providers based in Germany.
