## Promising new blood test to predict preterm birth

Researchers at the *University of Auckland*, New Zealand, are working to develop a mid-pregnancy blood test to predict preterm birth. About 60 percent of preterm births occur unexpectedly. At this stage, there is no way of reliably predicting if a woman is at risk of preterm delivery. A two-year study carried out at the *University of Auckland's Liggins Institute*, shall now verify whether a molecular fingerprint, detected in blood taken from women 20 weeks pregnant who all went on to have their babies early, could serve as a dependable biomarker for preterm birth.

## Babies are born with a throttled immune system

The high risk of neonatal death from sepsis is thought to result from the immaturity of the neonatal immune system. However, a new study by Viemann et al. from the *Hannover Medical School (MHH)* and the *Universities of Bonn (LIMES-Institute)* and *Münster* published in *Nature Immunology* observed hyperinflammatory courses of neonatal sepsis which contradicts this concept. The findings of the study could represent a valuable preventive option for newborn infants at high risk for sepsis.
