3rd Global Summit

The Bulgarian capital Sofia hosted the *3rd Global Summit for improving Standards of Care for Premies*. 140 leading healthcare experts and parents' representatives from 26 countries have met to discuss the most serious challenges preterm infants and their families have to face. The global meeting was organised by our partnering parent organisation *Our Premature Children Foundation*



in cooperation with the Bulgarian Society of Neonatology. EFCNI was represented by Silke Mader who gave a presentation on *Preterm infants – how should optimal discharge management – follow-up and long-term care look like?*

Testing and management of young children with fever

A research team from a Californian healthcare network published a study in *Pediatrics*: They analysed clinical diagnostic patterns regarding culture acquisition in young children aged 7 to 90 days with fever which are meant to test the presence of serious bacterial infections. In a 3-year study the authors revealed a big gap between scientific evidence and common clinical practice.

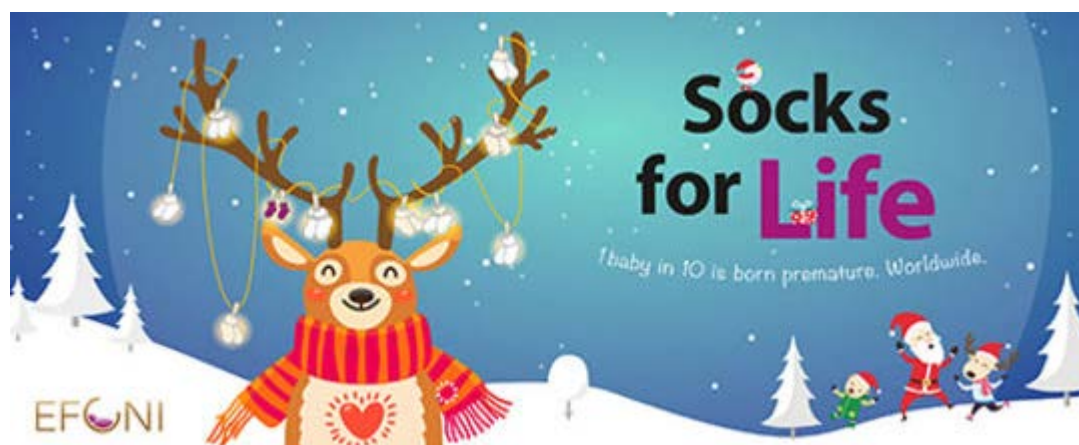
