

The Burden of Respiratory Syncytial Virus (RSV) on European health systems

The European Health Management Association (EHMA) conducted a cross-sectional survey of 380 healthcare professionals in paediatric hospitals in 20 European countries. The results confirm that the burden of RSV in paediatrics is significant, system-wide and affects all care settings. Following a thorough assessment of the health system disruption due to RSV, and the RSV-related health resources use in Europe, EHMA has developed recommendations aimed at investing in informing caregivers, clinicians, and policy makers, and building a more resilient and prepared health system for RSV in a multi-sectoral approach.

TWO INNOVATIVE RESEARCH PROJECTS ON BOARD

EFCNI is cooperation partner in the INSPIREand the COUSIN-study

The INSPIRE-study aims to describe current neonatal blood transfusion practices within Europe in order to develop and incorporate international guidelines into clinical practice. This shall avoid unnecessary blood transfusions in preterm born babies admitted to a Neonatal Intensive Care Unit. EFCNI coordinates an international parental advisory board (PAB) and provides input on topics related to ethics and patient information. The COUSIN-study aims to identify and establish an internationally endorsed Core Outcome Set for familycentred care practices in neonatal care. All relevant stakeholders, including parents and former patients, should be actively involved in order to help ensure uptake of the Core Outcome Set and implementation of family-centred care practices in neonatal intensive care.

META ANALYSIS

Psychiatric disorders in survivors born very preterm or at very low birthweight

Surveillance programmes for individuals born too small or too soon rarely extend beyond early childhood and focus on cognitive and motor outcomes. In their meta-analysis, the Adults born Preterm International Collaboration (APIC) team now compared the risk of developing psychiatric disorders between individuals born very preterm and/or at very low birth weight, and term-born, normal birth weight control participants. Study results suggest that monitoring mental health throughout development in these high-risk individuals may be beneficial to support early detection and treatment. The work was partly funded by the EU Horizon 2020 research and innovation programme under the "RECAP preterm" project, in which EFCNI is also involved.

The E-Learning course presents insights into very preterm cohorts, collaborative research principles, and techniques as well as new research on children and adults born very preterm based on pooled data. It also provides knowledge on how to implement a collaborative research protocol – including the ethical and legal requirements, procedures for harmonising data, the technological aspects of storing and sharing data, and analytic approaches and software. Participation in the e-learning course does not require any registration process.

E-poster on the process for the implementation of evidence-based parenteral nutrition in German perinatal centres presented at ADKA congress

Earlier this year, members of an expert panel on parenteral nutrition in neonatal care in which EFCNI is involved, published the article "Process for the Implementation of Evidence-Based Parenteral Nutrition in German Perinatal Centres – Outcomes of a Multidisciplinary Network". The results of this publication were now presented at the 47th annual congress of the ADKA, the Federal Association of German Hospital Pharmacists by ADKA member, and member of the expert panel, Dr. Sebastian Schubert in a poster presentation as well as in two more detailed talks. LIGHTHOUSE PROJECT IN FRANCE

Development of the Hospitalised Newborn Charta to strengthen the role of parents in the NICU

The Covid-19 pandemic has revealed unexpected consequences in neonatal units in France and worldwide, questioning the parents' role for the proper development of their hospitalised newborn baby. In order to avoid a recurrence of the separation practices encountered during the pandemic and to emphasise the essential presence of parents with their babies, the Hospitalised Newborn Charta was developed by our French partnering parent organisation SOS Préma. The charter was distributed to all neonatal units in France and defines in 10 points the essential needs of the hospitalised baby and how to meet them.

INSIGHTFUL COVID-19 PUBLICATION

EFCNI conducts study on parents' experiences regarding neonatal care during the COVID-19 pandemic

We are delighted to announce that our study "Parents' experiences regarding neonatal care during the COVID-19 pandemic: country-specific findings of a multinational survey" has been published. The COVID-19 pandemic has disrupted healthcare systems, challenging neonatal care provision globally. In this article, significant country-specific differences have been identified by focusing on 12 countries. It is shown that the application of infant and family-centred developmental care (IFCDC) is less prone to disruptions in some countries than in others. There is an urgent need to reconsider separation policies and to strengthen the IFCDC approach worldwide to ensure that the 2030 Development Agenda is achieved.
