FORTIFICATION

Launch of the German version of our factsheet on fortification in preterm and sick infants

We are happy to announce the launch of the German version of the EFCNI factsheet on "Fortification: nutritional additives for preterm and sick babies" ("Anreicherung: Ergänzung der Nahrung von Frühgeborenen und kranken Babys"), our newest asset for parents/caregivers and the broader public, which was first presented at the GNPI congress in Hamburg. Mother's own milk is the preferred option for infant nutrition. However, preterm, sick, or low birthweight infants need nutrients to ensure optimal growth and development. One way to meet these additional needs is the fortification of breastmilk. Supported by Priv. Doz. DDr. Christoph Binder, a well-versed expert in the field of paediatric nutrition, and our Parent and Patient Advisory Board member Gigi Khonyongwa-Fernandez, we provide an overview of the areas of application as well as types and components of fortification in preterm and sick babies. The aim of this factsheet is to raise awareness on the important topic of fortification in preterm and sick babies' nutrition.

Hemolytic Disease of the Fetus and Newborn (HDFN) is a rare pregnancy condition which occurs when the mother's red blood cells are not compatible with the red blood cells of her unborn baby (the fetus). To increase awareness for this condition and to facilitate communication between medical, specialised experts and patients, EFCNI developed a campaign addressing health professionals as well as women at risk of HDFN and women affected in a previous pregnancy, with targeted information. We are delighted that Professor Kypros Nicolaides supports this campaign with video statements on the risk assessment and monitoring of HDFN. NEW POSITION PAPER

RSV: disease burden, challenges, and opportunities in children in Germany, Austria, and Switzerland

At the 49th annual meeting of the Society for Neonatology and Pediatric Intensive Care Medicine (GNPI) in Hamburg last week, we presented our new RSV position paper. It was developed in close collaboration with leading experts from the fields of paediatrics, neonatology, immunology as well as paediatric nursing and parent representatives. The topic of RSV in children in the DACH region (Germany / Austria / Switzerland) was comprehensively discussed in several roundtable meetings, and, as a consequence, a call to action for decision-makers was developed. In particular, our experts stress the importance of raising awareness already now in preparation for the upcoming RSV season in autumn. Please note that the website and materials are in German.

MATERNAL HEALTH

New tool developed to detect and prevent excessive gestational weight gain

A group of researchers developed a practical questionnaire to help doctors, nurses, and midwives identify pregnant women at risk of excessive gestational weight gain (GWG) during pregnancy. Seeing that excessive GWG is linked to adverse health outcomes for mothers and infants, hopes are that this tool will help with its prevention. Results from the validation analysis were promising, as the questionnaire seems to accurately identify individuals at risk of excessive GWG. This proactive approach can potentially help with timely interventions, leading to better maternal and newborn health. The Technical University Munich and EFCNI's research team, including Senior Project Manager Dr. Julia Hoffmann, collaborated on this study.

NEWBORN HEALTH

Improving outcomes and empowering families with Kangaroo Mother Care

The World Health Organization (WHO) launched a Global Position Paper and an accompanying Implementation Strategy on Kangaroo Mother Care (KMC) last month. Taken together, these publications explain how KMC, a neonatal care practice, can be a life-saving intervention, especially for preterm and low birth-weight infants. They illustrate new findings and evidencebased recommendations for preterm care and call for systemic change in how maternal and newborn care are organised and conducted. Our latest research news summarises both papers and links to further educational material on the topic.

Board meeting for neonatal transfusion recommendations

DIGITAL PANEL MEETING

INSPIRE – International guideline initiative for neonatal transfusion clinical practice recommendations

This month, EFCNI and two parent representatives from our Romanian partner parent organisation ARNIS (Romanian Association of Long Hospitalized Newborns) and our Portuguese partners from XXS joined a digital panel meeting with international experts from the Neonatal Transfusion Network (NTN) to discuss current practice and summarise evidence from clinical trials on neonatal red blood cell transfusions. In the past, randomised trials were already completed and published, aimed at defining how to safely use red cell transfusion in preterm infants. Moreover, several surveys have shown wide variation in clinical practice, emphasising the need for an international guideline. The NTN has therefore formed a Steering Committee to develop clinical practice recommendations for neonatal transfusions – the INSPIRE study. The role of EFCNI, ARNIS, and XXS in this project is to give feedback and input from the patient and parental perspective.

RESQ FAMILY STUDY PROTOCOL

First publication released as part of EFCNI's ResQ Family project

For many families, life suddenly changed after their child needed to be hospitalised because of a severe infection with Respiratory Syncytial Virus (RSV). It is important to give these parents a voice and discuss the burden, the challenges as well as the unmet needs during these trying times. With the ResQ Family study, we investigate comprehensively the experience of caregivers of children who were hospitalised for RSV by applying a participatory research approach. We have now successfully published a study protocol which provides the scientific basis of the project. It defines the study design and objectives, describes the involvement of relevant stakeholders, and explains the recruitment of the study population. JOIN THE REVIEW PROCESS

Public consultation phase extended until the end of July

In order to ensure that the European Standards of Care for Newborn Health (ESCNH) remain up-to-date, each individual standard has its own lifecycle. Once the lifecycle is completed, a review becomes mandatory. Currently, 76 standards have concluded their lifecycle and now require revision to confirm that they continue to reflect the state of the art. We invite all healthcare professionals, parent representatives, and other stakeholders working in neonatal care to participate in the review process. The public consultation is open until the end of July. Please share your expertise with us!
