
MEMBER UPDATE

HUMAN MILK FORTIFICATION

New possibilities for preterm infant nutrition: Study highlights the benefits of human milkderived fortifiers

Traditionally, fortifiers derived from cow milk were considered the standard, but concerns have emerged about their nutritional adequacy. A recent study at the University Maternity Hospital Limerick has now unveiled the potential of Human Milk-Derived Fortifiers (HMDF). Results showcase HMDF's superiority in enhancing nutritional content and improving health outcomes. Fresh mother's own milk fortified with HMDF and given early, enterally, and exclusively (3E) was recognised as an optimal nutritional approach for preterm infants. Our partner parent organisation, the Irish Neonatal Health Alliance (INHA), was involved in the study from start to finish.

PREGNANCY HEALTH

EndObesity research project announces plans for scoping review to analyse why lifestyle interventions during pregnancy often fail

Lifestyle factors during preconception, pregnancy, and early childhood can increase the risk of childhood obesity. However, lifestyle interventions targeting the stages of preconception and pregnancy have yielded mixed outcomes. A scoping review protocol by the EndObesity project wants to elucidate why

interventions do not seem to show the desired results of preventing obesity in children. The comprehensive six-stage approach involves stakeholders from diverse fields and countries. As a third-party collaborator, EFCNI will participate in various consultation stages. The review's forthcoming publication wants to engage researchers, families, and practitioners invested in maternal and newborn health.

Case study shows: breastfeeding can save lives

This year's World Breastfeeding Week focused on how parents can integrate breastfeeding into their professional lives without compromising their baby's nutrition. Save the Children, a supporter of GLANCE's "Zero Separation" campaign, took this opportunity to draw attention to the precarious situation of parents and babies in crisis areas. It is not the daily work routine but war or environmental disasters which pose major obstacles to maintaining breastfeeding. An informative case study from Mozambique shows how help can be provided locally and remotely and how such measures could eventually save hundreds of thousands of infants and toddlers from death.
